Instructions to Bidders

- 2. Interested bidders must read this Notification and accompanying Tender documents, in detail. Any clarifications on the tendering process may be sought in writing toregistrar@nusrlranchi.ac.in.
- 3. The Sealed bid (including the Pre-Qualification Proposal and the Financial Proposal), duly filled and signed, is to be submitted to The Registrar, NUSRL, Ranchi, Jharkhand up to 15.00 hrs on03.11.2023. The bids will be opened in accordance with the Bid Schedule provided above at the office of The Vice Chancellor, National University of Study and Research in Law, Ranchi.
- 4. The Bid Proposal is to be submitted in two covers which shall comprise:
 - (i) Pre-Qualification proposal per clause 6.1 below.
 - (ii) Financial Proposal per clause 6.2 below.



5. Submission of Proposals

The bidders should submit their responses as per the format given in this RFP in the following manner:

- I. Pre-Qualification Proposal (1 Original) in first envelope
- II. Financial Proposal (1 Original) in second envelope
 - a. The response to Pre-Qualification Proposal and Financial Proposal (as mentioned above) should be covered in separate sealed envelopes super scribing, "Pre-Qualification Proposal" and "Financial Proposal" respectively. Each copy of each bid should also be marked as "Original" OR "Copy" as the case may be.
 - b. Please note that prices should not be indicated in the Pre-Qualification Proposal but should only be indicated in the Financial Proposal.
 - c. The two envelopes containing copies of Pre-Qualification Proposal and Financial Proposal should be put in another single larger sealed envelope clearly labelled in the prescribed format. The tender cover must be super scribed as below. "Response to RFP for < RFP Reference Number>Date of Opening"The tenders which are not superscripted as above are likely not to be opened before due date & may not be considered.
 - d. The outer envelope thus prepared should also indicate clearly the name, address, telephone number, E-mail ID and fax number of the bidder to enable the Bid to be returned unopened in case it is declared "Late".
 - e. All the pages of the proposal must be sequentially numbered and must contain the list of contents with page numbers. Any deficiency in the documentation may result in the rejection of the Bid.
 - f. The original proposal/bid shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except as necessary to correct errors made by the bidder itself. Any such corrections must be initialled by the person (or persons) who sign(s) the proposals.
 - g. All pages of the bid including the duplicate copies, shall be initialled and stamped by the person or persons who is authorised to sign the bid.
 - h. In case of any discrepancy observed by NUSRL in the contents of the submitted original paper bid documents with respective copies, the information furnished on original paper bid document will prevail over others.

6. Criteria for Evaluation of Bids:

6.1 Pre-Qualification Criteria

All interested bidders must meet the pre-qualification criteria specified. The University will only open and consider the Financial Proposals of those bidders who are found to have met all the pre-qualification criteria:

6.2 Financial Proposal

- a. The interested bidder shall quote its rates in the format provided in Annexure I Financial Proposal to this Tender on the basis of the website plan development structure at Annexure II- Website Plan / Sitemap for NUSRL.
- b. The **Website Plan/Site Map** in **Annexure-II** might have slight changes and bidder should support the required customizations.
- c. The Bidder or its Authorised Representative shall sign each page and affix the seal of the firm alongside.
- d. Only fixed price financial bids indicating total price (inclusive of all taxes except GST) for all the deliverables and services specified in this bid document will be considered.
- e. Any conditional bid would be rejected.
- f. Errors & Rectification: Arithmetical errors will be rectified on the following basis: "If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail".
- g. If there is no price quoted for certain material or service, the bid shall be declared as disqualified.
- 7. NUSRL shall have no responsibility for any delay; loss or non-receipt of bids sent by post.
- 8. Incomplete tenders without pre-qualifications will be rejected.
- 9. Rates quoted shall be exclusive of GST and any other applicable taxes, duties and levies.
- 10. Telex/Telegraphic, Tele-fax, E mail offers will not be accepted.
- 11. **Opening of Bids:** The University will open the Proposal covers of all the bidders received (except those received late or withdrawn) on the date specified in the Bid Schedule.
- 12. The Tender shall be valid for a period of not less than ninety (60) days after the date of opening of Tender.
- 13. Award: NUSRL will award the Contract to the successful bidder whose Financial Proposal is considered as substantially responsive as per the process outlined above. NUSRL reserves the right to accept or reject any proposal, and to annul the tendering process / Public procurement process and reject all proposals at any time prior to award of contract, without thereby incurring any

fiability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for NUSRL action.

- 14. **General Terms**: Contractors/ Agencies are subjected to be disqualified, even though they meet the qualifying criteria if they:
 - Provide misleading or false information in the request, statements and attachments submitted in proof of qualification requirement including withholding information.
 - Have a record of poor performance such as abandoning the work, not properly completing the
 contract, inordinate delays in competition, litigation history or financial failures, requesting for
 claims not admissible under the contract conditions etc.
